**A RESOLUTION OF THE TOWNSHIP OF FAIRFIELD, WESTMORELAND
COUNTY, PENNSYLVANIA APPOINTING THE VOTING DELEGATE AND
ALTERNATE DELEGATES TO THE TAX COLLECTION COMMITTEE (TCC)**

PURSUANT TO SECTION 505(b) OF THE LOCAL TAX ENABLING ACT.

WHEREAS, Section 505 (b) of the Local Tax Enabling Act requires townships that impose an earned income tax to appoint one voting delegate and one or more alternate delegates to serve as its Tax Collection Committee (TCC) representatives; and


WHEREAS, this Resolution is enacted pursuant to the Second Class Township Code and the Local Tax Enabling Act, as amended by Act 32 of 2008;


NOW THEREFORE, be it resolved and it is hereby resolved that:

1. This Resolution shall be known as the TCC Voting Delegate Appointment Resolution.
2. The following individuals are appointed as TCC delegates:

Primary Voting Delegate: Carrie Tantlinger
First Alternate Voting Delegate: Kelly Coursin
Second Alternate Voting Delegate: Vaughn Tantlinger
3. If the primary voting delegate cannot be present for a TCC meeting, the first alternate voting delegate shall be the representative at the TCC meeting. If both the primary voting delegate and the first alternate cannot be present for a TCC meeting, the second alternate shall be the representative at the TCC meeting.
4. These appointments are effective immediately and shall continue until successors are appointed. All delegates shall serve at the pleasure of this governing body and may be removed at any time at its discretion upon official action.

RESOLVED and ADOPTED into law this 10th day of March, 2022.
